 - 1. Water Quality Committee Jennifer Reek
 - Steve reported to move the WE Energies utility pole and Century Tel cable box it would cost \$20,000 to \$30,000. There is also an easement to address prior to asking to move the utilities. The easement is concerning both WE Energies and Panga Bar and Grill (Mike Eitel) for the dredging project staging area and a potential boat launch in the future. Another meeting to be set up with Mike Eitel. Brian Brenegan, resident next doorto land, has interest in the meeting.
 - To move forward with a re-survey to residence describing the dredging project and financing. Dan McCormack has financial impact for residents for a 20 year \$300,000 \$700,000 project costs. Steve suggested the survey to include the financial impacts.
 - Jennifer Reek needs to follow up with the DNR permit extension to 2023 and the July 1st October 15th project time frame.

 - JJ Alaily submitted a request on treatments of Eurasian Milfoil in Areas 1 and 3 of our management plan. \$7,000 for weed control is within the 2020 budget. Waiting on a response from the DNR for the permit to treat.
